DAYCARE & BOARDING CLIENT AGREEMENT

Hotel Bark Ave, LLC (Hotel Bark Ave) provides a safe, fun and stimulating environment for social, friendly dogs to play and exercise. To insure the health and safety of your dog and that of all our canine clients, we require all owners to complete and sign the following agreement.

This Agreement is entered on _____, by and between the above-named Owner(s), hereinafter referred to as “Owner”, and Hotel Bark Ave, LLC, hereinafter referred to as “Hotel Bark Ave”

In consideration of the daycare and boarding services provided by Hotel Bark Ave, Owner hereby agrees as follows:

1. Owner acknowledges that as of the date of this Agreement, the requirements for daycare and boarding services, fees and hours of operation are outlined below, and agrees to same. Owner further acknowledges that Hotel Bark Ave reserves the right to alter or amend the fees, hours and requirements in the future.

2. Each dog must:

- Must be at least 16 weeks of age.**
- Have current Rabies, Distemper/Parvo, and Bordetella vaccinations.**
- Must be spayed/neutered if older than 8 months.**
- Weight less than 50 lbs.**

3. Daycare and hours when dogs can be dropped off and picked up for boarding:

Monday to Friday 7 A.M. - 8 P.M | Saturday 10 A.M. – 6 P.M.

***Due to a clause in our lease we cannot accommodate drop-offs or pick-ups on Sundays in an effort to keep the barking down for our neighbors.**

Hotel Bark Ave is closed on Sunday and major holidays (Daycare only, boarding still available). All dogs must be picked up before 8:00 pm weekdays, and 6:00 pm on Saturdays, when open. Hotel Bark Ave will try to accommodate late pick-ups (up to 15 minutes), but Owner agrees to call ahead if he/she will be late, and not to make a habit of late pick-ups. Habitually late pick-ups will result in a late fee of \$10 for every 15 minutes (or fraction thereof) after 8 pm.

Reservations are required for boarding. All reservations can be made via email or by calling at least 24 hours before the stay would take place. In some instances we can accommodate same day reservations, however; space is limited. Reservations allow Hotel Bark Ave to staff appropriately for the number of dogs on a given day.

We send our invoices through Square and accept all major credit cards, Venmo (@BarkAve), and Zelle (HotelbarkaveLLC@gmail.com). Please submit a payment prior to your dog(s) stay, failure to do so will result in a late payment fee of \$10 per day.

We require 48 hour notice if you are canceling a weekend or holiday overnight(s). We schedule one of our staff to be with your pup, give him/her love and attention, 24/7 when he/she stays with us. We make this commitment and are here for you. Accordingly, if you reserve weekend or holiday overnights and cancel within 48 hours of your pup's scheduled stay, you will be charged for the first day and night of your reservation.

4. Owner agrees and acknowledges that in admitting my dog(s) to daycare or boarding, Hotel Bark Ave has relied upon my representation that my dog(s) is/are in good health, does not have and has not had within the last thirty (30) days any communicable diseases, and has/have not shown aggressive or threatening behavior toward any person or any other dog.

5. Owner acknowledges that daycare and boarding poses certain risks, including, but not limited to, contagious illness, parasites, and possible injury to my dog(s) and to myself. Owner hereby voluntarily assumes the risks associated with my dog(s) and/or myself participating in daycare and boarding, as well as the risks related to our presence on Hotel Bark Ave property, including, but not limited to, dog bites to humans and/or other dogs and the transmission of illness, disease and/or parasites.

6. Owner hereby authorizes Hotel Bark Ave, it's agents, officers, and employees to take whatever steps they deem necessary for the safety, health and well-being of my dog(s) while under the care of Hotel Bark Ave, including, but not limited to, engaging emergency veterinary services should my dog(s) require same, as determined by Hotel Bark Ave, in its sole discretion. Owner hereby accepts full responsibility for the payment of such

services and related expenses, and releases Hotel Bark Ave from any liability for payment for such services and expenses.

OWNER HEREBY RELEASES AND WAIVES LIABILITY AS FOLLOWS:

7. Owner acknowledges that my dog(s) may be captured on video, photography and/or other medium while under the care of Hotel Bark Ave, and hereby authorizes Hotel Bark Ave to use, broadcast and/or reproduce such images in video, print and/or other media.

Owner acknowledges and agrees that such images are the property of Hotel Bark Ave., and that Owner has no right to compensation for any use of such images by Hotel Bark Ave.

8. In consideration of the services rendered by Hotel Bark Ave, Owner hereby releases and discharges Hotel Bark Ave, its agents, officers, members, employees, sub-contractors, successors, assigns and all affiliated parties (hereinafter referred to as “the Indemnified Parties”), from any and all liability, claims, demands, causes of action, loss, damage and/or injury to myself, my dog(s), and/or my personal property, which may result while I, my guest(s) and/or my dog(s) are on the premises of Hotel Bark Ave, except to the extent caused by gross negligence or intentional misconduct of the Indemnified Parties.

9. Owner shall be responsible for myself, my guest(s) and my dog(s) and for any liability caused by me, my guest(s) and/or my dog(s), and shall hold harmless and indemnify Hotel Bark Ave and the Indemnified Parties, from any and all liability, claims, demands, causes of action, loss, damage and/or injury to any other person, dog(s) and/or personal property, which may be caused by myself, my guest(s) or my dog(s) while they are on the premises of Hotel Bark Ave.

10. Owner hereby certifies that he/she is eighteen (18) years of age or older, and has the legal capacity to enter into a binding contract under the laws of the State of New York.

11. Owner agrees that this Agreement shall be binding upon my heirs, assigns and successors in interest.
